Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issuance of an appropriate Writ, Order, or direction more particularly one in the nature of Writ of Mandamus, by declaring the order passed vide Rc.H.293/2025, dated 31.05.2025 by tribunal, under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (2019), in respect of directing the petitioners to deposit Rs.8,00,000/- in the name of 3rd Respondent and further directing to cancel the Gift settlement Deed in respect to Ac.0.10 Cents of site at Gannavaram on the name of 2nd Petitioner and to re-register the same in the name of 3rd Respondent, by not giving an opportunity, and personal hearing by exceeding the Jurisdiction, without jurisdiction, as illegal, arbitrary, Excessive and contrary to the principles of natural justice, violative of Fundamental Rights guaranteed under Article 14, 21 and 300-A of the Constitution of India and contrary to the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (2019) and Rules made therein, and consequently declare the same as illegal and void.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the proceedings Rc.H.293/2025, dated 31.05.2025 by tribunal, under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (2019), in respect of the direction i.e., petitioners to deposit Rs.8,00,000/- and direction to cancel the Gift Deed in respect to

Ac.0.10 Cents of site at Ganavaram, pending disposal of WP 20722 of 2025, on the file of the High Court.

Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issuance of an appropriate Writ, Order, or direction more particularly one in the nature of Writ of Mandamus, by declaring the action of the Respondent No.2 to 4 in cancelling the registered Gift settlement Deed vide 1667/2009, dated 30.04.2009 and Sale Deed dated 04.06.2025, vide Doc.No.5780/2025 registered at 4th Respondent, executed by the 2nd Petitioner in favour of 1st Petitioner in respect to Ac.0.10 Cents of site at Gannavaram Village, Krishna, through Letter No.NIL, dated 23.07.2025 basing orders passed, by Respondent No.2, vide Rc.H.293/2025, dated 21.07.2025 which are passed by modifying/improving the orders previous passed i.e., Rc.H. 293/2025, dated 31.05.2025 without referring to any law, section or Rules, without waiting till Appeal provision period (60 days), without giving any notice to the 1st Petitioner and further action of 4th Respondent issuing by not giving opportunity, and personal hearing by exceeding the Jurisdiction, without jurisdiction, as illegal, arbitrary. Excessive and contrary to the principles of natural Justice, violative of Fundamental Rights guaranteed under Article 14, 21 and 300-A of the Constitution of India and contrary to the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (2019) and Rules made therein, in view of the facts and circumstances set out hereunder.

Interim order granted earlier by this Court shall stand extended till the next date of hearing.

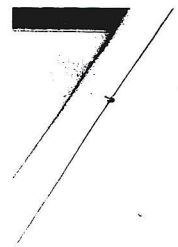
