Appeal under Section 55 of the Divorce Act, 1869, is filed against the Order passed in DOP No.91 of 2022, dated 11.03.2025, on the file of Principal District Judge, Prakasam at Ongole.

The Appeal coming on for hearing, upon perusing the Petition and the memorandum of grounds filed in support thereof and upon hearing the arguments of Sri Madhava Rao Nalluri Advocate for the Petitioner and the Court made the following.

ORDER

“The learned counsel for the appellant submitted that, despite his best efforts, the respondent is neither receiving nor accepting the notice and has left without furnishing any instructions.

In the said circumstances, the learned counsel requested this Court to treat the notice as deemed to have been served upon the

respondent. This Court is of the opinion that the present appeal arises out of the dismissal of the O.P. filed by the husband. If the respondent appears in the appeal after accepting notice, she would necessarily have to incur litigation expenses to contest the matter.

Having regard to the above circumstances, this Court deems it appropriate to direct the appellant to deposit a sum of Rs. 10,000/- towards litigation costs before the Principal District Judge, Prakasam District at Ongole. Upon such deposit being made, the Court below shall issue notice to the respondent through the concerned Judicial Magistrate, enclosing the notice along with the amount deposited towards litigation costs.
