Sri A.Sai Rohith, learned Assistant Public Prosecutor, on instructions, submits that in the present matter, a chargesheet has already been laid in C.C.No.2061 of 2025 on the file of the learned Special Judicial Magistrate of First Class (Prohibition & Excise), Kurnool.

Considering that one year has elapsed since the filing of the chargesheet and the Petitioners have not sought amendment of the prayer, it appears that the Petitioners are either not interested in prosecuting the matter or that the parties may have arrived at a settlement before the learned Trial Court.

In that view of the matter, the Criminal Petition is disposed of with liberty to the Petitioners to challenge the chargesheet, if they are so advised, and if the same is still pending consideration before the learned Trial Court. There shall be no order as to costs.

As a sequel, interlocutory applications, if any pending, shall stand closed.
