WHEREAS the Petitioners above named through their Advocate Sri M Delhi Babu presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or orders more particularly one in the nature of Writ of Mandamus declaring the action of the respondent Nos. 2 to 4 in not providing police aid to the petitioners against the unofficial respondent Nos. 5 to 8 for the land to an extent of Ac. 1.10 cents in Sy.No. 133-1B, situated at Somireddypalli Village, B.Mattam Mandal, Y.S.R. Kadapa District as illegal, arbitrary, unconstitutional and violation of Articles 14, 16, 19 and 300-A of the Constitution of India and consequently direct the respondent Nos. 2 to 4 to provide the police aid to the petitioners against the unofficial respondent Nos. 5 to 8 for the land to an extent of Ac. 1.10 cents in Sy.No. 133-1B, situated at Somireddypalli Village, B.Mattam Mandal, Y.S.R. Kadapa District.
