Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order, or direction, more particularly one in the nature of Writ of Mandamus, declaring the inaction and delay on the part of the Respondents in releasing the bill amounts for the following works undertaken under GadapaGadapaku Mana Prabhutvam funds (i) agreement dated 27-11-2023 for Construction of drainage from Shamil Veerabhadrappe House to Veerabhadra Swamy Temple at Madhudi Village for Rs-4,04,506.25

(ii) agreement dated 27-11-2023 for Construction of C.C. drains from Hanumantharayappa House to Nagaratanamma House at Thonasanapalli for Rs- 4,69,900.30 as arbitrai, illegal and violative of Articles 14 and 21 of the Constitution of India, and consequently direct the Respondents to release the corresponding bill amounts forthwith, in the interest of justice and equity;

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to pay the bills amount to the Petitioner covered by the works under (i) agreement dated 27-11-2023 for Construction of drainage from Shamil Veerabhadrapa House to Veerabhadra Swamy Temple at Madhudi Village for Rs-4,04,506.25 (ii) agreement dated 27-11-2023 for Construction of C.C. drains from Hanumantharayappa House to Nagaratanamma House at Thonasanapalli for Rs- 4,69,900.30 forthwith, Pending disposal of WP 21038 of 2025, on the file of the High Court.

The petition, coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri.P MADHUKAR REDDY Advocate for the Petitioner, GP FOR PANCHAYAT RAJ RURAL DEV for Respondent Nos.1, R3 to R5, GP for Finance Department for R2 and the Court made the following.

ORDER:

The petitioner filed the aforementioned writ petition claiming amounts i) Rs.4,04,506.25/- in respect of the construction of a new drainage from Shamil Veerabhadrapa's house to Veerabhadra Swamy Temple in Madhudi Village and ii) Rs.4,69,900.30/- in respect of the construction of CC drains from Hanumantharayappa's house to Nagaratanamma's house in Thonasanapalli Village.

Learned Assistant Government Pleader for Panchayat Raj and Rural Development submitted written instructions of the Executive Engineer-4th respondent in respect of second work. However, no instructions are placed before this Court in respect of the first work.

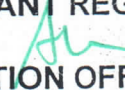
Learned Assistant Government Pleader for Panchayat Raj and Rural Development seeks time to get instructions.
