Court may be pleased to issue an appropriate Writ order or direction more
particularly one in the nature of Writ of Mandamus declaring the inaction of

the Respondents in disconnecting the electricity service connection bearing No.2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District, without following due process of law as is arbitrary, illegal, highhanded, and a colorable exercise of power, contrary to well-established legal principles and violative of the fundamental and constitutional rights guaranteed to me under Articles 14, 19, 21, and 300 A of the Constitution of India and consequently direct the respondents to restore the electricity connection bearing No. 2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District;

IA NO: 1 OF 2025:

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents to restore the electricity connection bearing No.2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District, pending disposal of WP.No.20789 of 2025, on the file of the High Court.
