

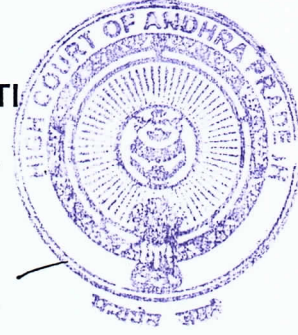

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the G.O.Ms.No.70 Home (General-B/A2) Department, dt.03.04.2014 and the G.O.Ms.No.70 Home (General-B/A2) Department, dt.03.04.2014 and the consequential orders dated 30-08-2017 in CrI.M.P.No.2083 of 2015 and dated 21.10.2019 in CrI.M.P.No.2904 of 2017 on the file of the Metropolitan Sessions Judge-Special Judge, Visakhapatnam under A.P. Protection of Depositors of Financial Establishment Act, 1999 as illegal and arbitrary and contrary to the provisions of A.P. Protection of Depositors of Finance Establishment

Act, 1999 consequently to set aside the same in so far as the Petitioners house plots bearing Plot nos.5 and 4, in Sy.No.17/18AA, AB,X,I,J,K,L,M,N,T,U,V,W of Sankarvarm Village, Anakapalli Mandal, Visakhapatnam district covered under sale deeds dated 04.09.2010 (Doc.No.2493 of 2010) and sale deed dated 04.09.2010 (Doc.No.2492 of 2010) in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all further proceedings pursuant to order dated 21.10.2019 in Crl.M.P.No.2904 of 2017 on the file of the Metropolitan Sessions Judge Special Judge, Visakhapatnam to try the cases under A.P. Protection of Depositors of Financial Establishment Act, 1999, Pending disposal of WP 21157 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri G Rama Gopal, Advocate for the Petitioner, Assistant GP for Home for the respondent Nos. 1 to 4 and of GP for Stamps and Registration for the respondent No.5, the Court made the following

ORDER:

“It is submitted by the learned counsel for the petitioners, acceded to by the learned Assistant Government Pleader for Home, that the issue involved in the petition is squarely covered by the order dated 05.5.2021 passed by this Court in W.P.No.8733 of 2021.

In view of the same and the reasons recorded in the order dated 05.5.2021 passed by this Court in W.P.No.8733 of 2021, there shall be interim stay of the order dated 21.10.2019 in Crl.M.P.No.2904 of 2017 on the file of the Metropolitan Sessions Judge-Special Judge to Try the cases under A.P. Protection of Depositors of Financial Establishments Act, 1999, Visakhapatnam, subject to the condition that the petitioners shall not alienate or create charge over the said property.”
