ORDER:

This Writ Petition is filed under Article 226 of Constitution of India with the following prayer for:

“...to issue a writ, order or direction more particularly one in the nature of a writ of mandamus declaring the action on the part of the respondent No.4 and 6 in interfering with the construction of shed in petitioners property i.e., in Sy.No.72-2A, 70-2B, to an extent of 02.400 Cents of Goturu Village, as illegal, arbitrary and violative of Articles 19, 21 and 300-A of the Constitution of India and consequently direct the respondents No. 4 to 6 and not to interfere with the construction of shed in petitioners property i.e., Sy.No.72-2A, 70- 2B, to an extent of 02.400 Cents of Goturu Village, Valluru Mandal YSR Kadapa District and pass.....”

2. Heard Sri S.Rama Lakshmana Reddy, learned Counsel for the petitioners and Sri V.Farooq, learned Assistant Government Pleader for Home for the respondents.

3. Learned counsel for the petitioners would submit that the police are interfering in the construction of sheds in petitioners' property and a direction may be given to the police not to interfere with the construction.

4. Learned Assistant Government Pleader would submit that the Court may pass appropriate orders.

5. Considering the submissions made, the writ petition is disposed of with a direction to the respondent authorities to follow due process of law in case of any deviation in the alleged construction by the petitioner. The police are directed not to interfere in the civil dispute, since there is a direction to the

respondents to follow the procedure according to law. There shall be no order as to costs.

As a sequel thereto, miscellaneous petitions pending, if any, shall stand closed.

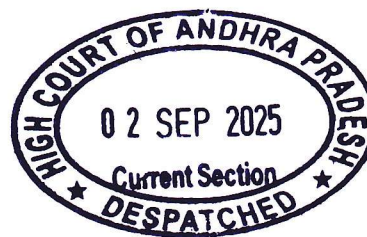
