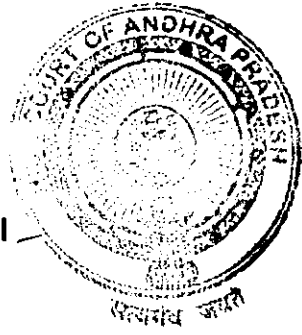

WHEREAS the Petitioner above named through her Advocate Sri G Tuhin Kumar presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Orders or directions more particularly one in nature of Writ of Mandamus, declaring the action of the respondents in not issuing the ST Caste Certificate, Benthoriya to the petitioner despite making the application for issuance as per the Act and Rules, Andhra Pradesh Schedule Castes, Schedule Tribes and Backward Classes - issuance of Community, nativity and date of birth certificates Act and Rules 1997 as illegal, arbitrary, unconstitutional, contrary to the Provisions of the Andhra Pradesh Schedule Castes, Schedule Tribes and Backward Classes - issuance of Community, nativity and date of birth certificates Act and Rules 1997 and consequently direct the respondents to issue the Benthoriya ST Caste Certificate, to the petitioner as per the law. ✓

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri G Tuhin Kumar, Advocate for the Petitioner, GP for Tribal Welfare for Respondent Nos.1 to 4 & 6 and M/s. S. Praneetha, Standing Counsel for Respondent No.5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted. —

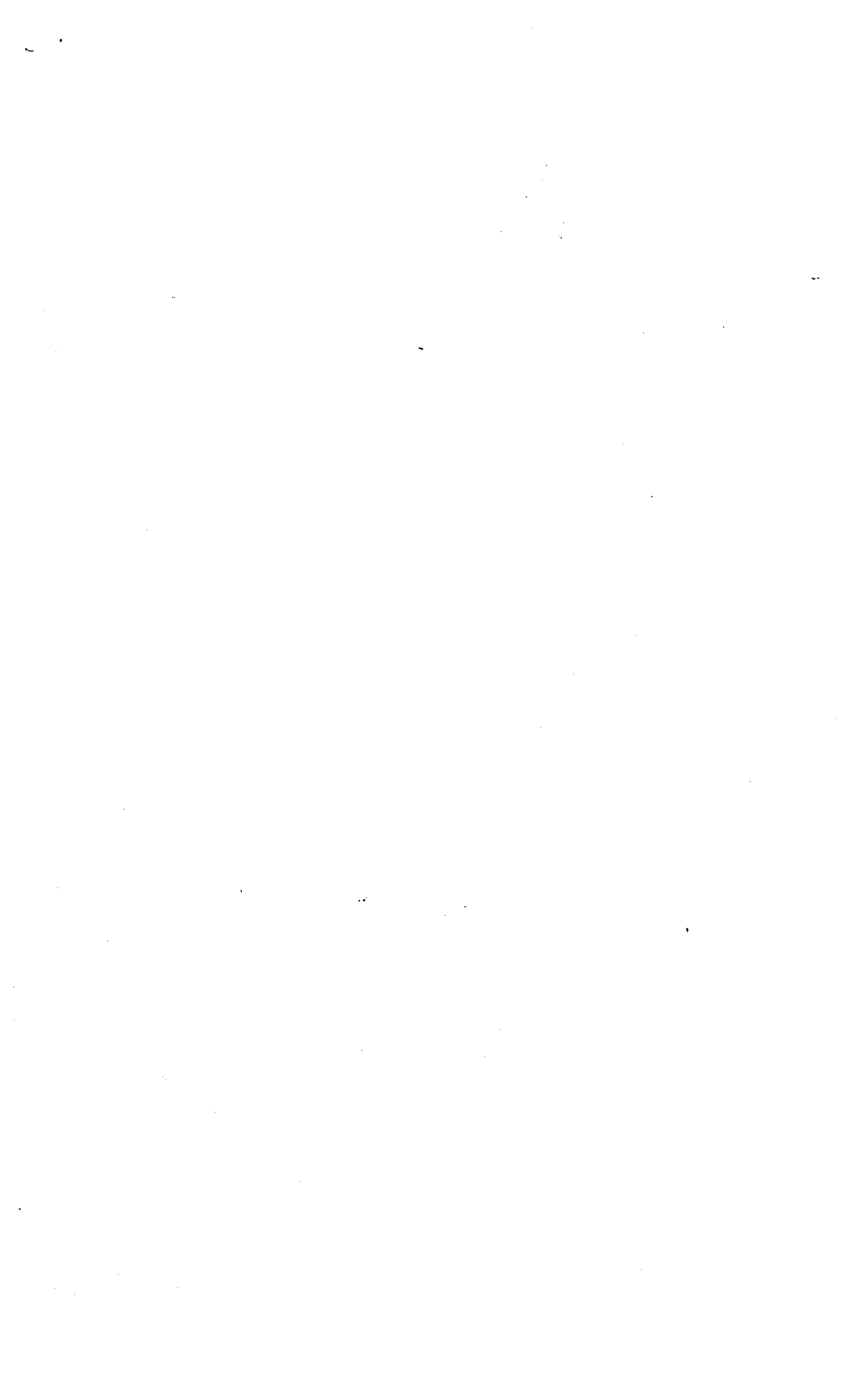
