WHEREAS the petitioner above named through his Advocate SRI N SIVA REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents in getting the Petitioner retired at the age of 60 years without extending the benefit of enhancement of the age of superannuation from 60 to

62 years on par with the other Government employees as per G.O.Ms.No.15 Finance (FIR.IV FR and LR) Department, dated 31.01.2022 and Section 115 - C and D of Andhra Pradesh Co-operative Societies Act, 1964 as illegal, arbitrary and violative of Articles 14, 19 and 21 of the Constitution of India and consequently direct the Respondents to permit the Petitioner to work as Chief Executive Officer in the 5th Respondent Society till he attains the age of 62 years in consonance with G.O.Ms.No. 15 Finance (HR.IV FR and LR) Department, dated 31.01.2022.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI N SIVA REDDY Advocate for Petitioner, and of GP FOR COOPERATION, for the Respondent Nos.1 to 3, and of SRI SRINIVAS BASAVA, Standing Counsel for the Respondent No.4, directed issue of notice to the Respondent No.5, herein to show cause as to why this WP should not be admitted

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the affidavit/memorandum of grounds filed therewith (copy enclosed) this WP should not be admitted

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to permit the Petitioner to work as Chief Executive Officer in the 5th Respondent Society till he attains the age of 62 years in consonance with G.O.Ms.No.15 Finance (HR.IV FR &

LR) Department, dated 31.01.2022, pending disposal of WRIT PETITION 22402 of 2026, on the file of the High Court

The Court made the following: ORDER

1. Notice before admission.
2. Learned Government Pleader for Co-operation takes notice for Respondent Nos. 1 to 3.
3. Learned Standing Counsel for DCC Bank takes notice for the Respondent No.4.
4. Issue notice to Respondent No. 5
5. Learned counsel for the Petitioner is also permitted to take out personal notice to Respondent No. 5 by RPAD and file proof of service in the Registry.
6. The present Writ Petition is filed questioning the action of the Respondents in not extending the benefit of enhanced age of superannuation from 60 to 62 years to the Petitioner pursuant to the resolutions of the Executive Committee as well as the General Body of the Respondent Society and to declare the same as illegal and arbitrary.
7. The learned Government Pleader submits that the Division Bench of this Court in W.A.No.649 of 2024 had passed an interim order on 11.09.2024 suspending the order of the learned Single Judge with regard to the same relief.
8. Heard the respective counsel.
9. The learned counsel for the Petitioner submits that though the Division Bench of this Court in W.A.649 of 2024 had stayed the enhancement of age of superannuation of 62 years, the distinguishable factor in this case is that the General Body as well as the Executive Committee of the Respondent-Society had resolved to enhance the age of its employees on par with the Government employees i.e., 62 years. Apart from that Rule 28(7)

of the Andhra Pradesh Co-operative Societies Rules enables the Society to enhance the age of its employees on par with the Government employees. In W.A.No.649 of 2024, the interim orders were passed at the instance of the Co-operative Society which did not pass any General Body or Executive Committee resolution as done in this case.

10. In that view, there shall be interim order as under;

(i) The Respondents shall continue the Petitioner till he attains the age of 62 years pending further orders.

11. Post this case along with W.P.No.16226 of 2026.

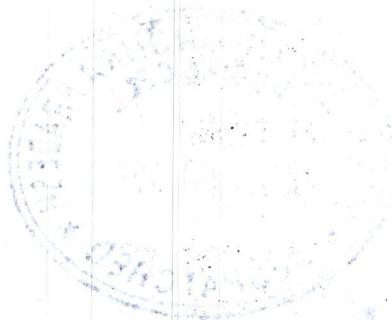
