Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction, more in the nature of Writ of Mandamus declaring the action of the Respondents herein, more particularly Respondent Nos.4 to 6 herein in interfering with the peaceful possession, entry, occupation and enjoyment of the Petitioner over the subject lands admeasuring an extent of Ac.2.39cents situate in Sy.No.103-C, an extent of Ac.1.44cents situate in Sy.No.110-1K and an extent of Ac.2.07cents situate in Sy.No.110-2B of Chuttagunta Ramapuram Village, Ramachandrapuram Mandal, Tirupati District, as being illegal, arbitrary, in violation of Art. 14, 21 and 300-A of the Constitution of India, and in violation of the settled principles of law, and consequently, direct the Respondents herein not to interfere with the peaceful possession, entry, occupation and enjoyment of the Petitioner over the subject lands admeasuring an extent of Ac.2.39cents situate in Sy.No.103-C, an extent of Ac.1.44cents situate in Sy.No.110-1K and an extent of Ac.2.07cents situate in Sy.No.110-2B of Chuttagunta Ramapuram Village, Ramachandrapuram Mandal, Tirupati District.

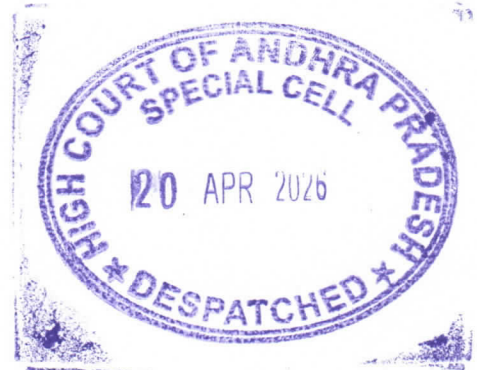
