AMARAVATI LAW CHAMBERS, presented this Petition under Section 482 of BNSS./438 of Cr.P.C., is filed praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to grant anticipatory bail to the petitioner / Accused in the event of his arrest in connection with Crime No.106 of 2026 on the file of Kasibugga Police Station Srikakulam District, registered for the offences punishable under Sections 310(2), 319(2), 61(2), 111 (2)(b) and 111 (6) of the Bharatiya Nyaya Sanhita, 2023, and Sections 25, 27 and 35 of the Arms Act, 1959, by directing

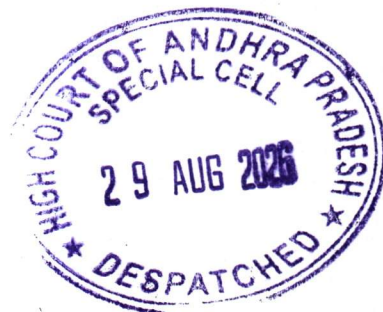
