As a last chance, list this matter after two (02) weeks for filing counter affidavit, failing which the 2<sup>nd</sup> respondent shall appear before this Court virtually."

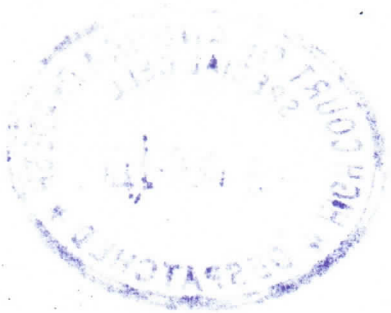
