THE HONOURABLE SRI JUSTICE VENKATESWARLU NIMMAGADDA**CONTEMPT CASE NO:1569 OF 2013****ORDER:**

This contempt case is filed against the respondents for willful disobedience of the orders dated 11.06.2013 passed by this Court in I.A.No.2 of 2013 (WPMP 19735 of 2013) in W.P.No.16285 of 2013.

2. No representation on behalf of the petitioner. Heard learned counsel for the respondents.
3. Even though the present contempt case pertains to the year 2013, the same came up for hearing on 31.03.2026. On 31.03.2026, none appeared and the matter was posted today under the caption 'for dismissal'. Even today, there is no representation on behalf of the petitioner.
4. On perusal of the record, it appears that the writ petition itself is allowed in part on 20.09.2024. In view of the disposal of the writ petition rights of the petitioner might have been complied with as per the orders of this Court long back. In view of the same, learned counsel for the petitioner is not pursuing the matter. In fact there is no material before this Court, whether the orders of this Court are complied with or not. Since the interim orders passed by this Court are merged with the final orders passed in the writ petition. Therefore, the contempt case filed against the interim order dated 11.06.2013 passed by this Court in

W.P.No.16285 of 2013 cannot be enforced. Hence, no further orders are necessary.

5. Accordingly, the Contempt Case is closed. There shall be no order as to costs.

Consequently, Miscellaneous Petitions, if any, pending in the contempt case shall stand closed.
