Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the grounds filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring that the action of the respondents herein in interfering with the possession and enjoyment of the Petitioner's land admeasuring an extent of Ac.2.65 Cents in Survey No.992-3 of Daditota Village, Tadimarri, Dharmavaram, Satyasai District, A.P, without issuing any notice and without following due process of law as wholly illegal, arbitrary, unjust, untenable, without jurisdiction, contrary to principles of Natural Justice, besides being violative of Article 14, 21 and 300-A of Constitution of India;

Petition under Section 151 CPC is filed praying that in the circumstances stated in the ground filed in support of the petition, the High Court may be pleased to direct the respondents not to interfere with the possession and enjoyment of the Petitioner in his land admeasuring an extent of Ac.2.65 Cents in Survey No.992-3 of Daditota Village, Tadimarri, Dharmavaram, Satyasai District, A.P, Pending disposal of WP 22606 of 2023, on the file of the High Court.
