List on 24.07.2026.

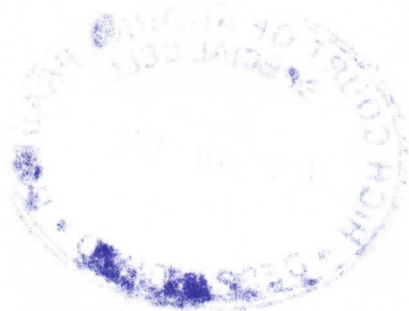
