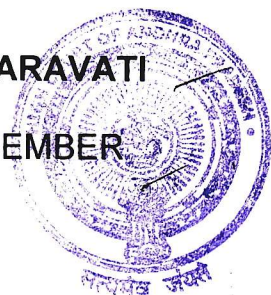

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the lower court to prepare the decree in O.P. 1248 of 2009, Pending disposal of FCA No. 250 of 2012, on the file of the High Court.

The court, while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

This is an application filed seeking to direct the trial Court to prepare the decree in O.P.No. 1248 of 2009 and to pass such other orders.

Learned counsel for the petitioner submits that he preferred the appeals against both the O.Ps, which were numbered as F.C.A.Nos. 249 and 250 of 2012. He submits that due to sending of bundle to this Court, decree in O.P.No. 1248 of 2009 is not prepared. He further submits that due to non-preparation of decree, judgment could not be enforced and thereby a lot of inconvenience is caused to the petitioner as the respondent failed to pay the amount as per the judgment.

Learned counsel for the respondent has not disputed the said submission.

Considering the said submission made and the record does not show the preparation of decree, the request of the petitioner is considered, with a direction to the trial Court to prepare the decree in O.P.No. 1248 of 2009, within a period of two (02) weeks from the date of receipt of the record.

Registry is directed to send back the lower Court record and after preparation of decree, the trial Court is directed to forthwith send the record without any delay.
