ORDER

"Heard the learned counsel for the petitioners.

Perused the record:

Earlier, by order dated 18.11.2021, stay of all further proceedings in Cr. No.103 of 2020 was granted. The learned counsel for the petitioners submits that the prayer in the earlier petition was not only to stay all further proceedings in the said crime but also further proceedings in C.C. No.3289 of 2021 on the file of IV Additional Judicial First Class Magistrate Court, Rajamahendravaram. The learned counsel for the petitioners submits that C.C. Number was not mentioned in the operative portion of the order and as a consequence of it, learned Magistrate is proceeding further with the case and hence, seeks stay of all further proceedings.

Considering these facts, the present application is allowed granting stay of all further proceedings in Cr. No. 103 of 2021 and C.C. No.3289 of 2021 before the learned IV Additional Judicial First Class Magistrate Court, Rajamahendravaram, till further orders."
