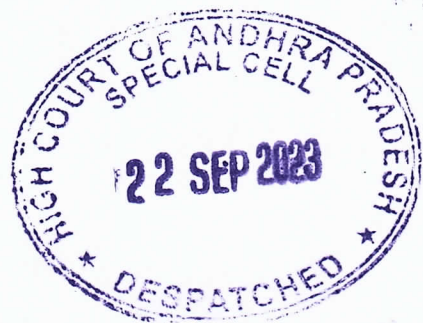

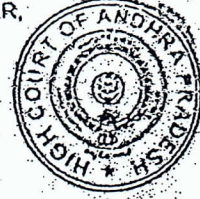

ORDER:

"This is an application filed by the petitioner under Section 151 C.P.C., seeking a direction to the respondent/N.Harish Kumar to undergo medical examination in respect of the sexual potency.

When the matter is taken up, it is submitted by the learned counsel for the respondent/ appellant on instructions that the respondent/appellant is ready to undergo medical examination in Gandhi Medical College, Hyderabad. It is further submitted by the learned counsel for the respondent/appellant that the petitioner/respondent herein may also be directed to undergo medical examination in the said hospital and the learned counsel for the petitioner/respondent on instructions expressed his willingness for the said course of action.

In view of the same, the appellant as well as the respondent in the appeal, who are respondent and petitioner in the present application, are hereby directed to undergo medical examination as to the sexual potency/rigidity in Gandhi Medical College, Hyderabad, subject to payment of necessary charges by the respective parties.

Office to communicate the order to Superintendent, Gandhi Medical College, Hyderabad, so as to enable the hospital authorities for constitution of medical board and for sending intimation in advance to the parties by registered post with acknowledgment

due as to the date of examination, subject to payment of costs by the respective parties."
