This contempt case is filed against the respondents for willful disobedience of the interim orders dated 15.11.2022 passed by this Court in W.P.No.5669 of 2020.

2. This Court passed an interim order dated 15.11.2022 in W.P.No.5669 of 2020 directing the respondents to continue the petitioners in service by paying minimum time scale attached to the post, pending disposal of the Writ Petition.

3. It is observed that due to passing of the final order in Writ Petition, the contempt case against the interim order cannot be enforced. Hence, no further orders are required to be passed in this Contempt Case.

4. Accordingly, the Contempt Case is closed. No order as to costs.

Consequently, Miscellaneous Petitions, if any, pending in the contempt case shall stand closed.
