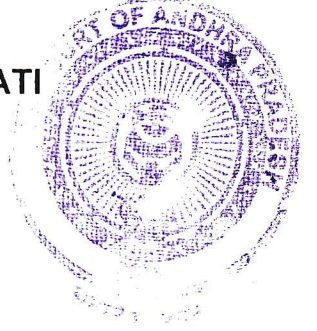

WHEREAS the Petitioner above named through his/her Advocate Sri V.V.L.N.PURNESH presented this Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order or direction more particularly the one in the nature of Writ of Certiorari calling for the records relating to Dairy No.287/2025 on the file of Debts Recovery Appellate Tribunal, Kolkata and to quash the order passed by the Hon'ble DRAT, Kolkata in I.A.No.163/2025 dated 30.07.2025 as illegal, high handed, arbitrary, erroneous and against to the principles of natural justice and consequentially to direct the respondents to deposit the pre deposit amount of 50 percent of the Debt amount as per the recovery Certificate issued by DRT, Visakhapatnam in RC No. 286 of 2024 in OA No. 552 of 2021 with upto date interest and costs as per the provisions of Section 21 of RDDB Act 1993 for entertaining the said appeal by DRAT Kolkata;
