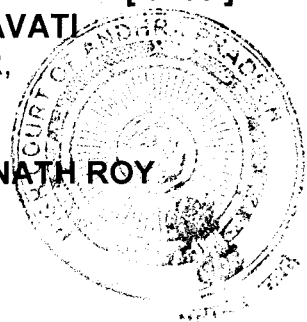

Petition under Section 482 of Cr.PC., praying that in the circumstances stated in the memo of grounds filed in CrI.P., the High Court may be pleased to stay all further proceedings in F.I.R. No. 447 of 2021, dated 24-08-2021, on the file of Nandyal II Town Police Station, including the arrest of the petitioner, pending disposal of CRLP No. 6757 of 2021, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and memo of grounds filed in CrI.P., and upon hearing the arguments of Sri Ghanta Sridhar Advocate for the Petitioner, and of Public Prosecutor for Respondent No.1, the Court made the following

ORDER:

Having regard to the facts and circumstances of the case, this Court is of the considered view that investigation shall go on and the same cannot be interdicted.

However, as the offences registered against the petitioner are all punishable with less than seven (07) years period of imprisonment, the investigating Officer is directed to follow the procedure contemplated under Section 41A Cr.PC and the guidelines prescribed by the Apex Court in Arnesh Kumar V. State of Bihar and another {(2014) 8 SCC 273} case against the petitioner.
