The Superintendent of Police, Kadapa, YSR Kadapa District.

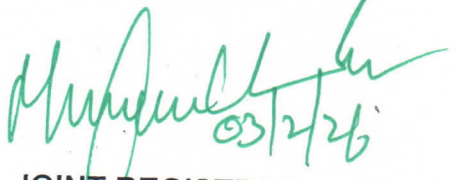

You are further directed that if the said respondent furnishes personal bond for a sum of Rs. 10,000/- (Rupees Ten thousand only) with two sureties each for a like sum with an undertaking affidavit that they will appear before
