WHEREAS the Petitioner above named through its Advocate Sri.HANUMANTHA RAO BACHINA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondent Nos. 1 to 4 in not deleting the 'Petition Scheduled Property' from the prohibited list of properties and consequently not receiving the Sale Certificate in respect of the said Respondent No.5 under the guise that the said property is under prohibitory property and not process the same for registration in favour of the list under the letter vide Lr.C.No. 42/2023 dated 25.04.2023 in violation of the provisions of the SARFAESI Act 2002 and is arbitrary, illegal and contrary, in violation of fundamental rights of the schedule property form the Prohibitory category and to receive the Sale consequently direct the respondent Nos. 1 to 4 to delete the petition Certificate issued in favour of the respondent No.5, process the same for registration and release the same to them.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri HANUMANTHA RAO BACHINA, Advocate for the Petitioner and of GP FOR STAMPS & REGISTRATION, for the Respondent Nos. 1 to 4 directed issue of fresh notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.

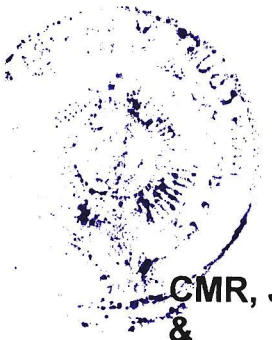
