Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased toto issue a writ order or direction especially one in the nature of writ of mandamus declaring that a) application of Andhra Pradesh Public Employment (Organization of Local cadres and Regularization of Direct Recruitment order) to the posts in A.P. Secondary Education Society under the control of Rastriya Madyamika Siksha Abiyan is illegal 86 arbitrary, therefore violative of article 371(D), Andhra Pradesh Public Employment (Organization of Local cadres and Regularization of Direct Recruitment order) 1975 and article 16 (1) (2) & (3) of the Constitution of India. b) declare that petitioner with Hall ticket No.41035400071 having securing 62 marks out of 100 is entitled to be selected in the vacancies reserved for BC(B)

community as PGT Zoology. c) further declare that non selection of the petitioner while selecting person who secured lower marks than the petitioner is violative of article 14, 16 & 21 of the Constitution of India. d)declare G.O.Ms.No.25, dt; 4-4-2013 to the extent it prescribes selection procedure making Andhra Pradesh Public Employment (Organization of Local cadres and Regularization of Direct Recruitment order) applicable for selection and appointment to the post in AP Secondary Education Society under the control of Rastriya Madyamika Siksha Abiyan as illegal.
