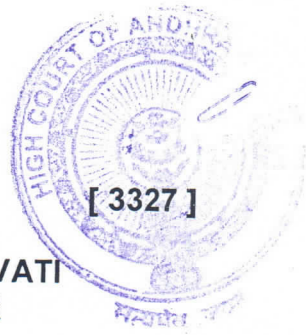

Presence of the petitioner No.2 i.e. A1 before the trial Court is dispensed with, except on those dates when the learned Magistrate feels that the presence of petitioner No.2 i.e. A1 is necessary.

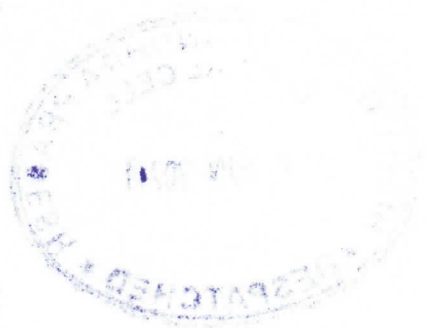
