JUDGMENT:

The instant Criminal Revision Case is filed under Sections 397 and 401 Cr.P.C against the Order dated 03.06.2024 passed in I.A.No.873 of 2022 in M.C.No.98 of 2022 on the file of Judge, Family Court – cum- VI Additional District and Sessions Judge, Nellore.

2. Heard Sri S.R.A.Rosedar, learned counsel for the Petitioner and Sri Siva Prasad Reddy Venati, learned counsel for Respondent No.1. Sri K.Sandeep, learned Assistant Public Prosecutor is in attendance.

3. Learned counsel for the Petitioner would submit that the petition may be disposed of by giving a direction to the trial Court for speedy disposal of the matter.

4. Learned counsel for Respondent No.1 also submits that the Court may pass appropriate orders and they will cooperate for the quick disposal of the matter.

5. As can be seen from the record, the maintenance has been filed before the trial Court in the year 2022 and the same is still pending. It is represented that the matter is coming up for cross examination of P.W.1. It is also represented that Respondent No.1 / Husband has not been attending the Court and that is why the matter has been adjourning from time to time.

6. Considering the submissions made, the Criminal Revision Case is disposed of. However, the learned trial Judge is directed to dispose of M.C.No.98 of 2022 as expeditiously as possible, without granting any adjournments in a casual way by mere asking and communicate the progress of the matter to the Registrar (Judicial) by 01.04.2026. Both parties are directed to cooperate for the disposal of the matter.

Pending applications, if any, shall stand closed.
