WHEREAS the Petitioner above named through its Advocate SRI.VENKATESWARA RAO GUDAPATI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondent authorities in not paying an amount of Rs.3,28,81,196/- from 2017-18 Kharif season till 2022-23 Kharif season towards the Custom Milled Rice supplied by the petitioner to the Respondent Corporation, as arbitrary, illegal, null and void, against the Norms of Public Policy and Principles of Natural Justice and to issue consequential direction directing the respondent authorities to pay the amount with interest @ 18% per annum to the petitioner.

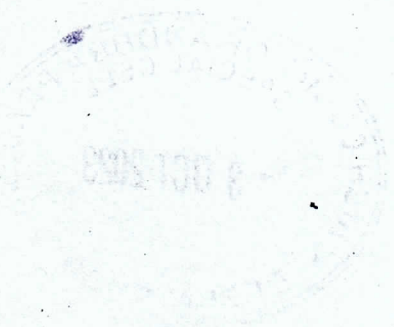
