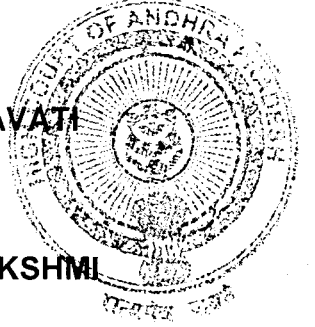

WHEREAS the Petitioner above named through his Advocate Sri Simhachalam Karukola presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a [5:42 pm, 28/12/2021] Raghuram Pulimi: writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the respondents in withholding the payment of balance an amount 26,25,000/- even after completion of works and obtained completion Certificate, payable to the petitioner in relation to the works of three GTW Ashram girls Schools i.e ., "providing toilets & bathrooms, flooring and toilets basins, pipelines, septic tank cleaning, Drainage works, school class rooms dormitories, kitchen repairs doors, windows and wall plastering and flooring, Electrical wiring & lighting, CLF bulbs, Tubes and outside lights were fixed and painting school buildings" of Three GTW Ashram girls Schools 1). GTW Ashram School (Girls), Gandhinagaram, G. Madugula, Visakhapatnam Dist, 2). GTW Ashram School (Girls), Kothuru, G. Madugula, Visakhapatnam Dist, 3). GTW Ashram School (Girls), Nurmathi, G. Madugula Mandal, Visakhapatnam District, is illegal, arbitrary, violation of principle of natural justice and consequently direct the respondents to consider for payment of amounts of Rs. 26,25,000/- with interest @ 24% per annum for the delayed amount to the petitioner in respect of execution of above mentioned work forthwith

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Simhachalam Karukola Advocate for the

Petitioner and GP for Tribal welfare for Respondent Nos.1, 3 to 6 and GP for Finance for respondent Nos.2 & 7, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
