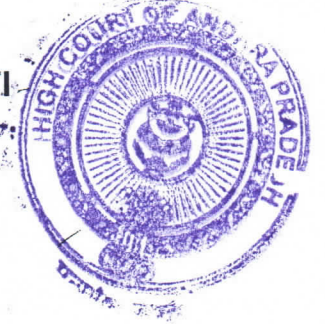

WHEREAS the Petitioner above named through his Advocate Sri DEVI PRASAD MANGALAPURI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or direction or order, one more particularly in the nature of Writ of Mandamus declaring the action of the Respondents in issuing the impugned proceedings in R.Dis.No.M2/972/1996, dated 30.07.2024, as illegal, arbitrary and in contravention of the provisions of the Endowments Act in particular under Section 80 of the Act and consequently to set aside the impugned proceedings in R.Dis.No.M2/972/1996, dated 30.07.2024 by directing the Respondents to execute a Conveyance Deed in accordance with law pursuant to the auction which was conducted on 09.07.1997 on receiving balance sale consideration.
