Learned counsel for the petitioners is permitted to take out personal notice on the respondent No.2 through Registered Post with acknowledgement due and file proof of service.

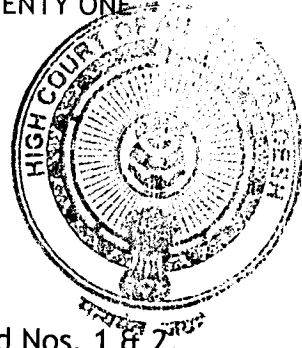
Post after four (04) weeks.
