Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Certiorari or any other appropriate writ, order or direction to declare the order of the DRT-2, Hyderabad in S.A.No.14/2022, dt.25.04.2025 as illegal, arbitrary, against principles of natural justice and violation of Article - 300A of Constitution of India and consequently direct the respondent bank not to proceed with the auction pursuant to the Sale Notice Ref. No.7700- BR/2752/2025-26/SL/JKCS/09, dt.08.09.2025 without demarcating the petitioner's land of an extent Ac.0.39 cents in Sy.No.563/C, situated at Pyalakurthy village, KodumuruMandal, Kurnool District by setting aside the orders in S.A.No. 14/2022 on the file of DRT-2, Hyderabad, dt.25.04.2025;

of three (3) weeks from today.**

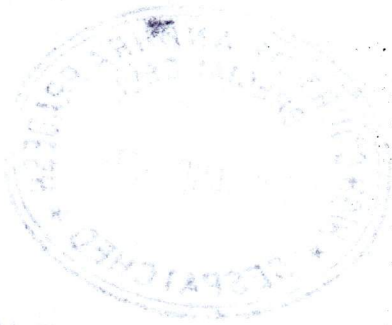
