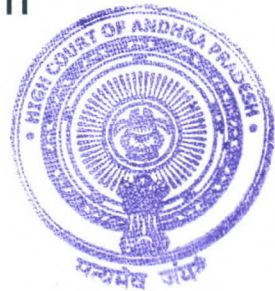

ORDER:

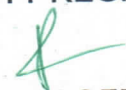
“Respondent appeared physically before this Court.
