14,19,21 of the Constitution of India apart from being violation of principles of natural justice and consequently direct the 3rd respondent to return original certificates which were kept with them while joining the BDS Course in their college academic the year 2022-2023.

ORDER:

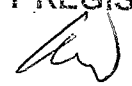
Learned Standing Counsel for respondent No.2 seeks time to file counter-affidavit.
