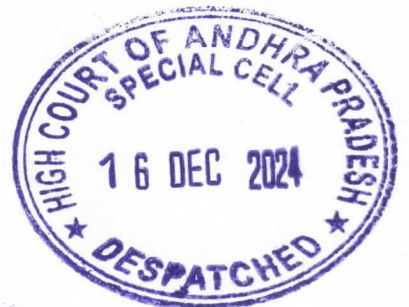

Therefore, you viz:

The Superintendent of Police, Krishna District

are hereby directed to arrest the said 3rd respondent viz; The Principal, Dr.Sudha Nageswara Rao Institute of Dental Sciences Chinna Avutapalli, Gannavaram, Krishna District A.P, wherever the said person is found and produce him/her bodily under safe custody and conduct before this Court on **26-12-2024** at 10:30 A.M., to which date the case stands posted.

You are further directed that if the said respondent furnishes bail bonds for a sum of **Rs. 10,000/- (Rupees Ten thousand only)** with an undertaking that he/she will appear before this Court on **26-12-2024**, he/she may be released on bail subject to the condition that he/she shall attend this Court on 26-12-2024 and shall continue to attend this Court until otherwise directed.

You are also further directed to return this warrant as early as possible preferably on or before 26-12-2024 to this Court with a detailed report stating the manner in which it has been executed.

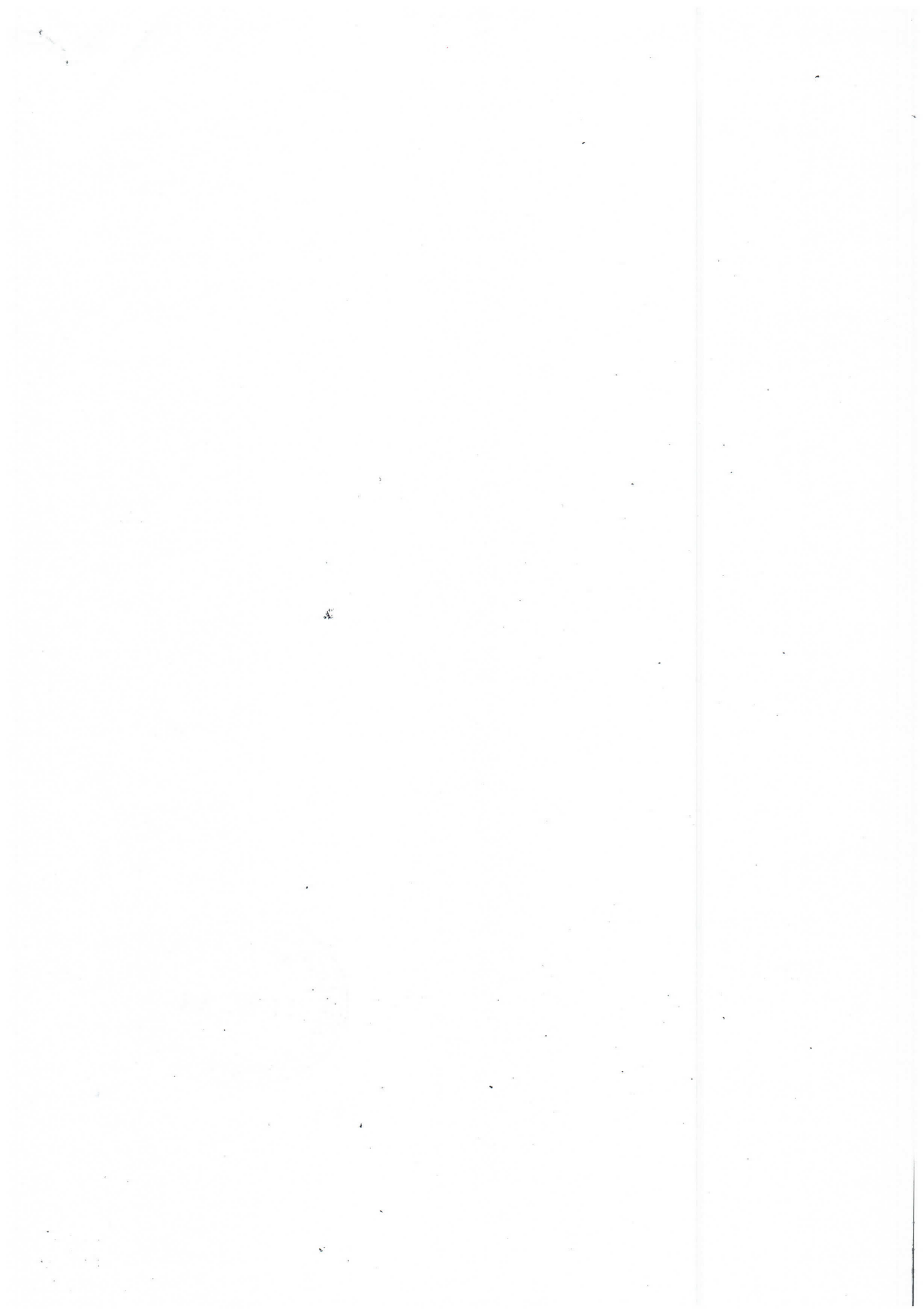
