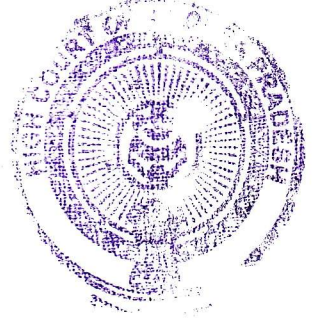

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order, or Direction, more particularly in the nature of a Writ of Mandamus, declaring the action of the respondents 3 to 5 in not issuing notice to the petitioner in respect of the auction issued by the 4th respondent vide RC. A. No. 2037/2025 dated 27.09.2025, as illegal, arbitrary, and violative of the fundamental rights guaranteed under Articles 14, 19, and

21 of the Constitution of India, and contrary to the express provisions of the Essential Commodities Act, 1955 and consequently, set-aside the auction Notice issued by the 4th respondent vide RC. A. No. 2037/2025 dated 27.09.2025.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the auction Notice issued by the 4th respondent vide RC. A. No. 2037/2025 dated; 27.09.2025, Pending disposal of WP 27835 of 2025, on the file of the High Court.

The Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI K SRINIVAS Advocate for the Petitioner, and of GP FOR CIVIL SUPPLIES, for the Respondents, the Court made the following

ORDER:

At request of learned Assistant Government Pleader for Civil Supplies, post the matter on 14.10.2025.

Till such time, the operation of the notice issued by the 4th respondent vide Rc.A.No.2037/2025, dated 27.09.2025 shall be suspended, only with regard to the stocks pertaining to the petitioner at Sl.Nos.1, 3, 4 and 5 of the said impugned notice. However, the respondents are at liberty to proceed with the auction with regard to other items of the said notice.
