WHEREAS the Petitioner above named through their Advocate Sri Sravan Kumar Naidana presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or mandamus any other appropriate writ or direction declaring the action of the respondent in withholding the payment an amount of Rs. 24,63,671/- even after finalizing the bills, payable to the petitioner in relation to the work i.e., **“Construction of Compound wall to Burial Ground in Kota (V) of Meedipentla Gp of Vemula mandal In YSR Kapada District,”**, vide allotted to the Token Bill No. 2024-173550, (old token bill No. 2023-9009026) in vide agreement No. 2370008992/2023-24, Dated 11-10-2023, as the same is illegal, arbitrary and consequently direct the respondents to consider for payments of Rs. 24,63,671/- with interest @ 12 % per annum for the delayed amount to the petitioner in respect of execution of above-mentioned work forthwith.
