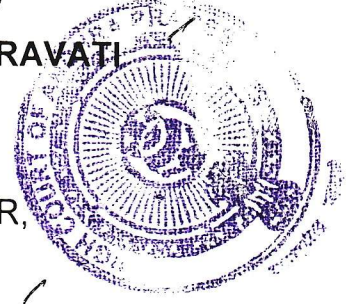

WHEREAS the Petitioner above named through his Advocate Sri.SIVA RAMA KRISHNA KOLLURU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or direction or order more particularly one in the nature of Writ of Mandamus declaring the G.O.Ms.No. 120, MA&UD(M) Department, dated. 13-07-2025, and the annexed guidelines titled, Self Certification Scheme (SCS)- 2025, as illegal, arbitrary and ultra vires the provisions of the Greater Hyderabad Municipal Corporation Act, 1955, the Andhra Pradesh Municipalities Act, 1965, the A.P. Municipal Corporations Act, 1994, the A.P. Capital Region Development Authority Act, 2014, and the A.P. Metropolitan Region and Urban Development Authorities Act, 2016, as the same amounts to impermissible sub-delegation of statutory powers in violation of the doctrine of delegatus non potest delegare, and in violative of Articles 14 and 19(l)(g) of the Constitution of India and consequently set aside the G.O.Ms.No. 120, MA &UD(M) Department, dated. 13-07-2025 and guidelines annexed to it.

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri SIVA RAMA KRISHNA KOLLURU Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
