

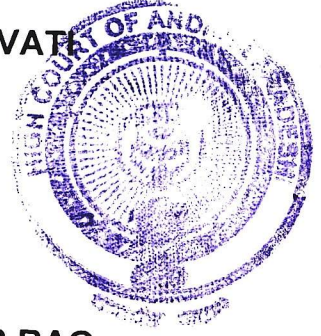

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order, or direction, particularly one in the nature of Writ of MANDAMUS, declaring the action of the respondents in constructing the waste management shed, dumping waste, and burning the same in Sy. No. 219 of Bethapudi Village, Phirangipuram Mandal, Guntur District (classified as Vagu), as illegal, arbitrary, ultra vires, and violative of

natural justice, and Articles 14, 21, and 300-A of the Constitution and consequently direct the respondents to forthwith remove the waste management shed, cease all dumping and burning activities in Sy. No. 219, and restore the land to its original state as a natural stream, within a time-bound manner, in the interest of justice.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to DIRECT the respondents not to dump waste or burn the same in Sy. No. 219 of Bethapudi Village, Phirangipuram Mandal, Guntur District (classified as Vagu) or in any open place, Pending disposal of WP 28384 of 2025, on the file of the High Court.

The Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI KAMBHAMPATI RAMESH BABU Advocate for the Petitioner, and of GP FOR PANCHAYAT RAJ RURAL DEV, for the Respondent No.1, and of GP FOR REVENUE, for the Respondent Nos.2 & 3, and of SRI Y.SOMARAJU, Standing Counsel for the Respondent No.4, and of SRI M.SUDHIR, Standing Counsel for the Respondent No.5, the Court made the following

ORDER:

The respondent No.5 is hereby directed not to dump any waste material, garbage in the Vagu (stream) in Survey No.219 of Bethapudi village.
