

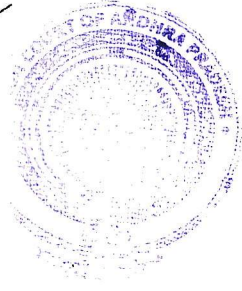

WHEREAS the Petitioner above named through his/her Advocate NALLANAGULA LALITHA SREE presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or direction particularly, one in the nature of writ of Mandamus declaring the action of respondent authorities in not considering the representation dated 01/09/2025 in not removing the encroachments from the petitioners land situated at Survey No. 81 of extent Ac. 5.92 cents situated at Achayapalem Village, Buttayagudem Mandal, Eluru District in view of the orders passed by the 3rd respondent in SR. No. 155/77 Dated 16.03.1979 is as illegal, arbitrary and violation of principles of natural justice and the act of authorities is against the principle laid down by the Hon'ble Apex court in the case of RAME GOWDA V/S M VARADAPPA NAIDU Citation 2003 LawSuit(SC) 1248 and consequential direct the respondents not to consider the representation dated 01/09/2025 accordingly to the procedure established by the law in view of the orders passed by 3rd respondent in SR.NO. 155/77 Dated 16/03/1979;

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri NALLANAGULA LALITHA SREE Advocate for the Petitioner, GP FOR TRIBAL WELFARE for Respondent Nos.1, 3, 6 & 7, GP FOR

REVENUE for Respondent Nos.2, 4 & 5 directed issue of notice to the Respondent Nos.3 to 6 herein to show cause as to why this WRIT PETITION should not be admitted
