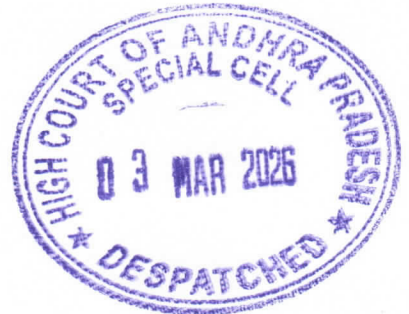

You are further directed that if the said respondent furnishes personal bond for a sum of Rs. 10,000/- (Rupees Ten thousand only) with two sureties for a like sum each with an undertaking affidavit that he will appear before this Court on **31.03.2026**, he may be released on bail subject to the condition that he shall attend this Court on **31.03.2026** and shall continue to attend this Court until otherwise directed.

You are also further directed to return this warrant as early as possible preferably on or before **31.03.2026** to this Court with a detailed report stating the manner in which it has been executed.
