Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ or Order or a direction, more in the form of writ of mandamus, declaring the action of the Respondents in not making payment of Rs. 17,34,360.43/- (Rupees Seventeen Lakhs Thirty Four Thousand Three Hundred and Sixty and Forty Three Paise Only) to the petitioner for the execution of Construction of Compound Wall and Filling Infront of Building to

Low Lying Area to MPSB at Vemula of YSR District, vide Agreement dated 29.09.2023, as highly illegal, irregular, arbitrary, unreasonable, unjustified, unfair and in violation of the Article 14,19and21 of the Constitution of India and consequently direct the Respondents to make the payment of aforementioned amount forthwith along with interest @ 24 percent P.A., to the petitioner and pass
