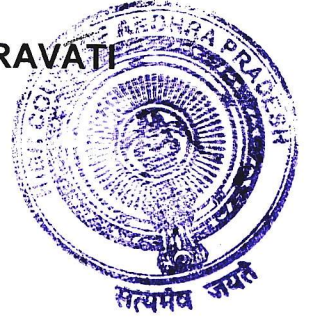

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction on the part of the respondent No.2 to 7 in releasing an amount of Rs.22,60,022/- (Rupees Twenty Two Laksh Sixty Thousand and twenty two rupees only) in favour of the petitioner for the work executed by me towards providing drinking water to the Virupapuram and 12 other habitations under O and M (Operation and Maintenance) of CPWS Scheme for the year, 2023-2024 and consequently action of respondents No. 2 to 7 in taking steps to release the above said payments to the respondent No.8, having stated that, he failed to execute the work entrusted in his favour and he is not entitled to claim any payments as arbitrary, illegal, contrary to the well established legal principles, apart from being violative of the fundamental rights guaranteed to him under Articles 14, 19 and 21 of the Constitution of India and consequently direct the respondents No.2 to 7 to release an amount of Rs.22,60,022/- (Rupees Twenty Two Laksh Sixty Thousand and twenty two rupees only) in favour of the petitioner for the work executed by me towards providing drinking water to the Virupapuram and 12 other habitations under O and M (Operation and Maintenance) of CPWS Scheme for the year, 2023-2024.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents No. 2 to 7 not to pay the amount of Rs.22,60,022/- (Rupees Twenty Two Laksh Sixty Thousand and twenty two rupees only) to the respondent No.8 for the work executed by me towards providing drinking water to the Virupapuram & 12 other habitations under O & M (Operation & Maintenance) of CPWS Scheme for the year, 2023-2024, Pending disposal of WP 29574 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri V R Reddy Kovvuri, Advocate for the Petitioner, Sri Panku Rajesh Kumar, Assistant GP for Panchayat Raj for the Respondent Nos.1, 4, 5, 6, 7, GP for Finance for the respondent No.2 and of Sri Mattegunta Sudhir, Standing Counsel for the respondent No.3, the Court made the following

ORDER:

2. Sri Panku Rajesh Kumar, learned Assistant Government Pleader, seeks time to obtain Written Instructions insofar as the payment to Respondent No.8 is concerned.

3. There shall be a direction to the Official Respondents not to make any payment to Respondent No. 8 until the next listing
