Aggrieved by the order and decree dated 11.11.2024 in Interlocutory Application No.655 of 2024 in Original Suit No.262 of 2011 on the file of the Court of Principal Civil Judge (Senior Division) at Eluru, West Godavari District, the present Civil Revision Petition is filed.

2. Sri Ch. Ganesh, learned counsel, representing Sri Sai Gangaadhar Chmarty, learned counsel for the petitioner, submits that the suit in O.S.No.262 of 2011 was decreed with costs, hence, the cause in the Civil Revision Petition does not survive and it has become infructuous.

3. Sri C.Venkaiah, learned counsel for the respondent concedes the same and submits that the Civil Revision Petition has become infructuous.
