The Court made the following order:

Aggrieved by the order dated 11.11.2024 in Interlocutory Application No.653 of 2024 in Original Suit No.291 of 2011 on the file of the Court of Principal Civil Judge (Senior Division) at Eluru, West Godavari District, the present Civil Revision Petition is filed.

2. Sri Ch. Ganesh, learned counsel, representing Sri Sai Gangadhar Chamarty, learned counsel for the petitioner, submits that the suit in O.S.No.291 of 2011 was decreed with costs, hence, the cause in the Civil Revision Petition does not survive and it has become infructuous.

3. Sri C.Venkaiah, learned counsel for the respondent concedes the same and submits that the Civil Revision Petition has become infructuous.
