Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction mostly one which is in the nature of a Writ of Mandamus declaring the action of the Respondents in non-payment of amounts due to the Petitioner even after finalizing the bills, payable in relation to the works executed in pursuance of works, i.e. (1) Ordinary maintenance of SH Roads in (R and B) Sections, Narsapuram and Mogaltur for the year 2022-23 due for an amount of Rs.9,38,495/- and (2) Urgent Repairs to Narsapuram - Turputulla Road from 0.000 to 8.000 in West Godavari District (WGMD063) due for an amount of Rs. Rs.15,16,622/- as illegal, arbitrary, unjust, unfair, unreasonable and unconstitutional and consequently direct the Respondents to make the payment of amounts due to the Petitioner in respect of above execution of works forthwith.
