WHEREAS the Petitioner above named through his Advocate SRI GANTA PRASAD presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order, or direction, particularly one in the nature of Writ of Mandamus, to set aside the proceedings issued by the District Cooperative Officer, Chittor i.e. 3<sup>rd</sup> respondent herein vide Rc.No.728/2024-C1 dated 24.08.2024 under which an enquiry under Section 51 of Andhra Pradesh Cooperative Societies Act, 1964 was ordered into affairs of the 7<sup>th</sup> respondent society contrary to provisions of APCS Act, 1964 so also to set aside the subsequent proceedings issued by the 5<sup>th</sup> respondent under Section 60(1) of APCS Act, 1964 vide Rc.No.690/2021-B dated 28.10.2025.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri GANTA PRASAD Advocate for the Petitioner, GP FOR COOPERATIVE SOCIETIES directed issue of notice to the Respondent Nos.6 & 7 herein to show cause as to why this WRIT PETITION should not be admitted.
