SAMEERA BOKKA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction particularly one in the nature of Writ of Mandamus to declaring the inaction on the part of the respondents herein, not releasing and pay the bill amounts worth of Rs.3,63,208/- with interest, to the petitioner for supply of material for execution of the works under the grant of MGNREGS with SDF as illegal, arbitrary and violation of Article 14, 16 and 21 of Constitution of India and consequentially to direct the respondents to release and pay the bill worth of Rs.3,63,208/- with interest, to the petitioner forthwith.

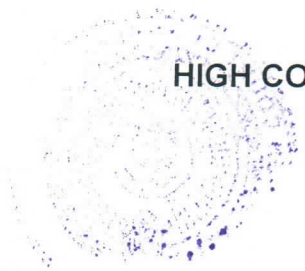
