Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction more particularly one on the nature of Writ of Mandamus It is therefore prayed that this Honble Court may be pleased to issue an appropriate writ, order or direction, more particularly, one in the nature of Writ of Certiorari calling for records in Proceedings Rc.No.587/2025/SA dated 04.10.2025 on the file of the Respondent Tahsildar as being illegal, unlawful, wholly without jurisdiction, vitiated by bias and violative of Articles 14, 19, 21 and 300A of the Constitution of India and consequently quash the same.
