A K KISHORE REDDY, presented this Petition under Article 226 of the Constitution of India, is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.2 in accepting the three man Committee

report submitted contrary to the proceedings issued by the District Collector, East Godavari District in E-file No.391951, dated 20.11.2021 and directing Respondent No.4 to take immediate action for implementation of the three member committee report without furnishing the copy of the same and also in instructing to remove the weed growth from Crop Canal No. 14 though it is far away from the Agricultural Lands of the Petitioners and not in use as nothing but illegal, erroneous, arbitrary and violative of The Constitutional Rights guaranteed to the Petitioners under Article 14, 21 and 300 A of The Constitution of India apart from the Proceedings issued by the then Respondent No.2 issued vide e-file No.391951, dated 20.11.2021 and consequently direct the Respondents No.2 to 6 to provide irrigation water to the Petitioners agricultural lands situated at Sy.No.169/1A,169/2A,2B belongs to the Petitioner No.1 and Sy. No. 171/4,5, 171/3A belongs to the Petitioner No.2 of Pathainjaram village, I.Polavaram Mandal, Dr.B.R.Ambedkar Konaseema District (Erstwhile East Godavari District) through Crop canal No. 15 available at Pathainjaram village, I.Polavaram Mandal, Dr.B.R.Ambedkar Konaseema District (Erstwhile East Godavari District)

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A K KISHORE REDDY Advocate for the Petitioner and of GP FOR IRRIGATION, for the Respondent Nos. 1, 3 to 5 and of GP FOR REVENUE, for the Respondent Nos. 2 & 6 directed issue of notice to the Respondent Nos. 7 to 11, herein to show cause as to why this WRIT PETITION should not be admitted.

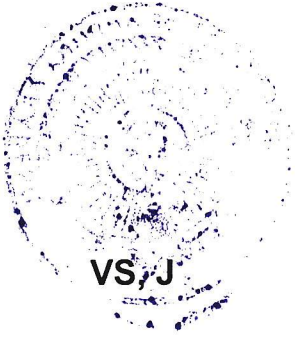
